- 1. Activate Dummy Sandbox Schemes in FundWare for testing purposes; SB0 SB7
- 2. Upload test data to these schemes
- 3. Funds-Axis to apply UCITS regulatory rules to these test schemes;
 - a. Generate a minimum of 1 breach and 1 pass result per UCITS rule
 - b. To validate a minimum of 1 breach and 1 pass result per UCITS rule
- 4. Funds Axis will provide documentation providing explanation of regulatory rule results

UCITS07: Rule Results

Results:

6 of 8 sandbox schemes are passing UCITS07

Cause:

This rule considers the eligibility of derivative underlying's. What is considered ineligible for the purposes of UCITS is listed out in the Rule Custom Attribute definition of "Derivative Underlying is Eligible" = No (Please see Appendix B).

The rule is using the RCA "Derivative Underlying is Eligible" = "No".

This RCA is set up only to classify those derivatives where underlying is eligible = "No", not those where it is yes. This RCA is set-up to be "No" for certain derivative assets types and unless they have been manually overridden as "Is UCITS Eligible Underlying Asset" = Yes; they will be classified as Not Eligible.
