UCITS20: Rule Results

Results:

2 of 8 sandbox schemes are passing UCITS20.

Cause:

If the underlying issuer for a security is a GOPS issuer, UCITS20 aggregates these holdings and determines if it reaches a 35% limit on the value of the fund. If the 35% threshold is exceeded, then UCITS20 will look at the number of issues held, if the number of issues is 6 or more, then the rule will pass. However if it is between 1 and 5 the rule will breach. UCITS20 will also pass if less than 35% of the NAV is held no matter how many issues are held.

Whilst strictly the rule works at issuer level, for practical purposes this rule works off issuer group rather than issuer.

E.g. In example 1 – "UNITED STATES OF AMER TREAS BONDS" and "UNITED STATES OF AMER TREAS NOTES" should in any case have the same issuer group of "US Government".

To test this rule there are three scenarios over which the rule should pass or breach. These scenarios are listed below:

- 1. If UL Issuer Group >35% with < 6 Issues: Breach
- 2. If UL Issuer Group >35% with =/>6 issues: Pass
- 3. If UL Issuer Group <35% with <6 Issues: Pass

Note:

This rule uses commitment exposure as a measurement rather than Market Value as it allows for a more representative view of derivatives for the purpose of UCITS20.

Commitment Exposure is calculated by the below formula:

(Quantity x Underlying Price x Delta x Multiplier)/ Underlying FX Rate

The below security is marked as having a GOPS issuer; which is also a 100% eligible GOPS issuer. It holds greater than 30% per issue (34.1%), as well greater than 35% per the UL Issuer Group (77.2%), therefore it is meeting all breach criteria for UCITS19; failing the rule.


