AIFMD Annex IV Reporting is the EU-wide harmonised data collection and reporting applicable to Alternative Investment Fund Managers (AIFMs), and is required under the Alternative Investment Fund Managers Directive (AIFMD).

Details on the information to be reported can be found in Annex IV to the Level 2 Regulation, hence the name "Annex IV Reporting." Annex IV affects Alternative Investment Managers (AIFMs) and Alternative Investment Funds (AIFs), including not only EU AIFMs and EU AIFs but also non-EU AIFMs and non-EU AIFs.
