For the purposes of this document, we will focus on the DQM_General reports.



A1.1 Data Quality Overview - Securities

This report gives a high-level overview of the overall data quality status for the security data held across your portfolios.

Across the data quality reports we expect to see zero values populated. This indicates that there are no data quality issues across your portfolios.

A1.2 DQ Asset types

DQM_General

This data quality report can be used to ensure that the set-up of specific types of securities has been completed correctly.

There are five reports to be monitored in this report:

- 1. Deposits not classified as deposits.
- 2. Depository receipts not classified as depository receipts.
- 3. Possible ETFs not classified as ETFs.
- 4. Misclassified as Investment Trusts
- 5. Assets incorrectly classified as index derivatives.

The detailed reports will flag any potential data quality issues with securities that are held across your portfolios.

It does not mean that every security that flags within the reports are data quality reports but can be used to identify possible issues.

As we can see from the screenshots, the detailed reports reflect the numbers that are appearing within the overview reports.

A1.3 DQ Exchange Codes

Assets incorrectly classified as index derivatives

For UCITS monitoring, we would expect most securities to be on listed exchanges.

The purpose of this data quality report is to flag any securities that we would expect to have an exchange populated e.g., equities, futures, closed ended funds etc that have a blank or OTC exchange populated.

For this report some instruments have been excluded e.g., cash.

As before, not all the instrument's flagging in these reports will be data issues. There could genuinely been OTC or unlisted securities held on your portfolios, but the reports within the data quality section could be used to determine what are data issues and need to be investigated and resolved further.

A1.3. DQ Exchange Codes Jul 21, 2023 10:06:19 AM

The report includes futures, equities, closed ended funds, & structured products.

For UCITS, we will expect most of these securities to be on exchange

The report excludes some instruments that will have exchanges (such as ETFs), index options, and some fixed income (i.e., GOPS).

A1.4. DQ Asset Class

This report can be used to identify which instruments do not have an underlying asset class assigned to them.

Although the underlying asset class will not impact your regulatory rules, it can be used for prospectus rules, so it is important to ensure that each instrument is assigned to an underlying asset class.

Please see appendix 1 on how to fix blank underlying asset classes.

A1.5. DQ Country Detail

This report can be used to identify any securities held across your portfolios that do not have a country of incorporation, or country of economic exposure assigned to them, or have an UNKNOWN value assigned to them.

We would expect every instrument to have a country of incorporation and country of economic exposure assigned to them.

A1.6. DQ Security Ratings

This report can be used to identify where we do not have a credit rating populated against Fixed Income and money market instruments (MMI). You can also amend the filters applied to the report to consider structured products if you choose to do so.

A1.7 DQ Manually set as transferable.

This report can be used to identify any equities, fixed income, MMI, closed ended funds, or structured products that have been manually marked as transferable in the system.

Once these securities have been marked as transferable manually, then this should prevent them from flagging as exceptions/breaches in your investment compliance report.

The securities that appear in these reports should be reviewed to ensure that they are in-fact transferable securities.

A1.8 DQ Derivatives manually set as reliable valuation.

This report can be used to identify which derivative and structured product instrument have been manually marked as having a reliable valuation.

Once these securities have been marked as having reliable valuation manually, then this should prevent them from flagging as exceptions/breaches in your investment compliance report.

The securities that appear in these reports should be reviewed to ensure that they do have a reliable valuation.

FUNDS AXIS

A2.3. DQ Funds invested into – Closed ended funds.

This report can be used to review the set-up of your closed ended funds across your portfolios.

We would expect all closed ended funds (including investment trusts) to be listed on an exchange and to have their fund structure marked as closed ended.

A3.1. Cash and Deposits Eligible Institutions

This report can be used to identify which counterparties are being used across your portfolios.

For example, we would not expect to see a counterparty of Tesco or BP used across your portfolios.

This report should be used to ensure that all counterparties used on your portfolios are eligible counterparties and would be considered acceptable deposit takers.

An acceptable deposit taker can be defined as below:

(a) if the account is opened at a branch in the United Kingdom:

- (i) the Bank of England; or
- (ii) the central bank of a member state of the OECD; or
- (iii) a bank; or
- (iv) a building society; or

(v) a bank which is supervised by the central bank or other banking regulator of a member state of the OECD; or

(b) if the account is opened elsewhere:

- (i) a bank in (a); or
- (ii) a bank which is regulated in the Isle of Man or the Channel Islands; or
- (c) a bank supervised by the South African Reserve Bank; or

(d) any other bank that:

(i) is subject to regulation by a national banking regulator.

(ii) is required to provide audited accounts.

(iii) has minimum net assets of ± 5 million (or its equivalent in any other currency at the relevant time) and has a surplus revenue over expenditure for the last two financial years; and

(iv) has an annual audit report which is not materially qualified.

A3.2. Government Issuers

This report can be used to review which issuers are being flagged as Government issuers, and to review any issuers that should be potentially categorised as Government issuers.

Please also see the document GOPS classification which outlines how Government issuers are determined in the security data.

Appendix 1 – Updating asset class

To update the asset class for a security, you can take the security identifier that appears for the security and search for the security in Manual Data Management, Securities.

Once in the security, go to the asset manual classification tab and update the field asset class with the relevant asset class to be applied.
